Friends of Warm Hearth, Inc. provides community-based group homes which prevent orphaned adults with disabilities or mental illness from being forced to live in psychiatric institutions in Armenia. We initiated the movement toward privatized mental health care and serve as a model for future projects in Armenia for the benefit of this vulnerable population.

In 2009, we offered ongoing long-term residential care to seven residents who have lived in Warm Hearth since 2006 as well as to six additional residents who have resided in Warm Hearth since 2008. We provided long-term ongoing support to one individual (former resident) who is living in a nearby clinic through conducting weekly therapeutic visits. We built the capacity of our staff and provided ongoing training to them to ensure that we are providing holistic care to our residents. Training topics in 2009 included: Crisis Management, Behavior Management Plans, Post-Traumatic Stress Disorder, and Emotional Management of Trauma. In the fall of 2009, eleven of our residents were able to begin attending a local university for a special education degree-granting program. Additionally, we continued our in-home programs to encourage the social, physical, mental and vocational well-being of our residents. Through these weekly programs, we facilitated community and societal integration. Individual Care Plans, which include data from the International Classification of Functioning, Disability and Health, continued to serve us and provided quantifiable data in regard to the growth and development of our residents.

The cost of operating the group home is \$89,321 in cash. This includes \$62,519 which was transferred in 2009 to Jermik Ankyun Foundation in Armenia and is reported in Part II, line 1 as a grant. The \$62,519 is monitored through daily correspondence between the Executive Director of Friends of Warm Hearth, Inc. and the Country Director in Armenia Jermik Ankyun Foundation, which provides support and control of the transferred funds. In addition, on-site visits are conducted on an annual to bi-annual basis and a comparison is made of budgeted versus actual expenditures. Lastly, the budget and expenditures are reviewed by the full Board of Directors.
