CMS3, LLC (CMS3), EIN 27-0470961, was the high bidder at a public foreclosure sale, resulting in its purchase of an asset from The Shumard Foundation (FDN) (which was the foreclosing party on a secured note issued by an unrelated borrower) on 9/1/2009 at fair market value (FMV)=\$1,500,000; in return for the sale price, CMS3 issued a note to the FDN=\$1,500,000, bearing interest at 4% per annum.

In analyzing the sale transaction for tax preparation purposes, it was not discovered until July 14, 2010 that CMS3 was considered a "disqualified person" under IRC Section 4958, due to the 5 year look back rules for supporting organizations, which were inadvertently overlooked by legal counsel. Since CMS3 paid FMV for the asset, it was mistakenly assumed that there was no deemed "excess benefit" to the transaction. The transaction was entered into under the advisement of legal counsel, and there was no intent of willful neglect.

After discovery of the deemed "excess benefit", CMS3 paid cash to the FDN=\$1,500,000, plus interest, on August 5, 2010 (within 22 days of its discovery). There was no economic benefit to CMS3 in this transaction, as they sold this asset to an unrelated third party for \$1,500,000 on June 30, 2010.

In summation:

1. The FDN entered into the transaction with reasonable cause, and under advice of legal counsel, and not with the intent of willful neglect; and
2. The transaction was corrected, as required by Federal Regulations. 53.4958-7, within 22 days of discovery;

Therefore the form 4720 filed for CMS3, is requesting an abatement of the excise tax under IRC Section 4962.


