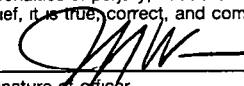

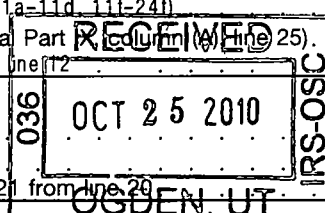

Lemonade Day Program

Lemonade Day is a nation-wide event that teaches kids the skills they need to be successful in the future. Youth learn to set goals, develop a business plan, establish a budget, seek investors, provide customer service, and give back to the community. Lemonade Day is the perfect opportunity for a community to show kids they care and train the next generation of entrepreneurs through a FREE, fun, engaging, experiential activity. Lemonade Day is funded through sponsorships and donations.

In 2009, P4L offered Lemonade Day in Houston and licensed the program to 2 other cities. Approximately 27,000 kids registered for Lemonade Day in Houston, TX and 4,000 kids registered in the licensed cities.

P4L's after-school programs offer asset-based experiential programs in the after-school hours at middle school campuses. These programs are funded by a combination of 21st Century Grants and Local Donations.

In 2009, P4L operated in 7 Houston area middle schools affecting approximately 1,000 students. With the end of the 2008/2009 school year, P4L ceased offering the after-school programs.
