They are as follows: The Paul David Clark Bicycling Safety Fund's mission is to encourage motorists to be more aware of bicyclists and to compel motorists and cyclists to respectfully share the road. The REI Bicycle Friendly Communities Grant Program, administered by the Bikes Belong Foundation in partnership with the League of American Bicyclists, supports designated and aspiring Bicycle Friendly Communities (BFC) who are demonstrating success, employing creative strategies, and showing marked advancements in becoming more bicycle friendly. This program helps cities maintain the significant momentum generated by the BFC application process. The program also utilizes the feedback provided to them by the BFC review team. Awards range from \$5,000 to \$15,000 and can be used for a variety of purposes from consulting and technical expertise to programs which generate ridership and promote bicycling. Support for the Alliance for Biking and Walking (formerly known as Thunderhead Alliance), which is the North American coalition of grassroots bicycle and pedestrian advocacy organizations. The Alliance works to unite advocacy leaders to help them become more effective by sharing best practices and innovations.
