



Part III- Program Accomplishments cont.

Meedan Inc. had other program expenses in the amount of \$342,343 for the following programs:

- Following the Launch of Meedan.net in late March 2009, our principal success has been in seeding a community of core users spanning the Arabic-English web. From a small team of beta testers based mostly in the United States, we now have a user base with majority representation from the Middle East. We believe our strategy of seeding this community from within the Arabic world distinguishes our initiative. In the space of our first nine months in the public view, we have achieved almost 600,000 absolute unique visitors. Much of this increase in traffic was driven by the huge growth in visits y Arabic speaking users, according to Google Analytics. Users classified as American English speakers grew by just 388% between May and September, compared to 6,550% increase in Saudi Arabic users and 1,643% increase in general Arabic users. Our translation team (volunteer plus staff) translated nearly 1.6 million words in 2009. As threads on Meedan .net and discussions on our translators mailing list attest, we have demonstrated that language learners and early career translators are motivated by opportunities to translate social commentary for a live audience and that translators will collaborate to improve upon translations.
- Meedan Technology- Community growth success in 2009 could not have been possible without a concerted development push which enabled public launch of the beta Meedan media exchange site on March 20th. Our community driven approach to translation combines the speed of machine processing with a human editorial layer. One of the most significant accomplishments for Meedan in 2009 was our release, under an open license, of the data (parallel corpora) generated as the byproduct of Meedan's translation community.
