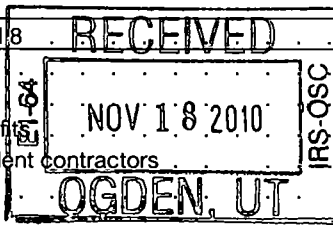

#### **Form 990-EZ, Line 29 – Educational Programs**

Designed to teach specific characteristics and skills that equip participants to be responsible and successful contributors in their own social circles and in the workplace. Programs included 1) Leadership training and character building – “Ladies of Strength” for girls – 42 served; “Men of Respect” for boys – 68 served; both meet weekly; “Being a World-Changer” – 9 youth served; “K-Kids” grade school program partnering with Mt. Prospect Kiwanis – 76 youth served; And help start a new “Builder’s Club Program at River Trails Middle School – 36 youth served 2) Job Search/Interviewing Skills, Mentoring – “Hire Up” – 49 served; 3) Job Training Seminars, presented at the Mt. Prospect Public Library – 10 served 4) On the job training – “Humble eXpressions” silkscreen & embroidery business for youth – 3 youth and 3 adults employed, and 2 additional youth provided with training for possible future employment, as well as 1 adult being provided training on equipment for possible future leadership roles.
