Micro Church Planting. Our main service as an organization is to help initiate and grow micro churches reaching different groups of people in the city. In 2009 we grew to have over 50 micro churches as a part of the Underground Network. These small churches provide many services to people in our community in need. They range from small fellowships that meet in people's homes to more wholistic ministries like one that provides housing and care for women seeking to leave the sex industry. We provide ongoing training and equipping for the leaders of these small churches as well as provide the overall structure for them to exist and operate within, logistically and otherwise.

4b (Code:) (Expenses \$ **52,336.83** including grants of \$) (Revenue \$)
Catalyst Program. Beginning in September of 2007, we began to offer a catalyst service to all of the small ministries (micro churches) that are a part of our network. It is a weekly gathering of between 250 and 300 people. The service provides a place of empowerment, equipping, and encouragement to all the leaders of the micro churches that are formed under our network. In addition, it serves as a time of envisioning new initiatives that could be started to reach different places in our city.

Ministry Center. As we have grown, the need for a ministry center in which micro churches can use to help them carry out the programs and services they desire to provide. We have always had a facility that has served this in some way, but this year we greatly expanded to provide a much larger facility that would serve all the micro churches in our network and provide a place for more initiatives to be nurtured and flourish. This program expense provides for a multi-use classroom, office space for many of these small ministries, and places for the micro churches to gather for meetings and conferences they desire to have.
