On Part III, Line 5 there is a difference of \$573. I do not understand why there is a difference. The only thing I can think of is this may be the interest we earned on the CD of \$584.32 that is earned and reported by our bank but in fact is a part of the \$15,000 CD sum and not added to the CD above and beyond the \$15,000. I don't know how to show this on your form, but I am guessing this would be the answer.

In a nutshell, we received \$15,620 in a donation from our founding trustee, paid out grants of \$2,000 to qualified charities. We earned \$68 on a one-day investment in the stock market. We earned \$772 in interest in the checking account and on the CD.
