It identifies major constituencies such as city governments, local heritage organizations, universities, etc. who wish to have input into the nature of the preservation. The Organization then locates experts who can plan and carry out the preservation and funds those experts. This process is overseen by the Organization's Senior Advisory Board, Program & Planning Committee and staff. During 2009, the Organization funded conservation planning and preservation projects in 11 sites around the world.
