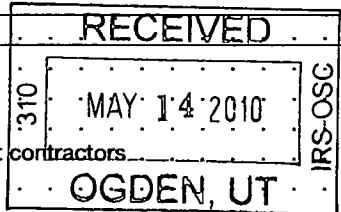

Our goal has always been to maintain a virtual highly qualified faculty to assure low overhead costs and to insure that we provide the highest quality relevant learning available to public leaders. Over the past year we provided Systems Thinking (originated at the MIT center for Organizational Learning) to leaders in the Department of Veterans Affairs throughout the country. We also helped to improve the civic leadership capacity of city leaders, university leaders and community land trust leaders through Facilitative Leadership Training.

As a pro bono offering we continue to provide a monthly teleconference as an opportunity for public leaders to share best practices and learn together on topics such as Ethics for Public Leaders and the new findings of Neuroscience and the impact on Leadership practices. We continue to work to develop new approaches to learning and to offer relevant topics that are on the frontier of public leadership such as Sustainable Leadership Practices and Transitions Skills for Leaders.

We continue to expand our partnerships with other like minded non profits who share our mission. The target audience for our work is vast (local, state and federal public leaders) and we realize that we cannot possibly provide learning opportunities to all the public leaders who need our services. Our web site [www.public-sector.org](http://www.public-sector.org) provides publications and resources to leaders who want to continue their education on their own. Our bibliography for public leaders is updated annually and is organized by essential areas of practice.

We will offer learning opportunities throughout 2009 as we continue to work on ways to lower our costs and keep our quality high so that leaders at all levels of government can access these important management and leadership professional skills and practices.
