

Revenue reported on line 2, Program service related revenue, \$208,365, was received from royalties on Buddhist books and recordings of Pema Chodron, the rights of which have been granted to the Foundation by the author, to facilitate the spread of Buddhist teachings and to provide an additional source of income to advance the goals of the Foundation. This arrangement is specified in the form 1023 Part VIII Paragraph 10, filed with the IRS and approved on Nov 11, 2007, and effective December 19, 2006. It states: "Pema Chödrön may contribute to the Foundation, the royalty rights and/or copyright in some of her publications to provide a source of on-going support." Her many books are published and sold by the commercial publisher, Shambhala Publications which represents about 59% of the royalties. The remaining 41% is primarily from recordings of her books and talks which are published and sold by Sounds True Recordings and Great Paths Tapes. These royalties are paid directly to the Foundation by the publishers.
