


THE CLEAN ENERGY FELLOWSHIP PROGRAM IS AN INNOVATIVE ENTREPRENEURIAL DEVELOPMENT PROGRAM DESIGNED TO RAPIDLY TRANSITION EXPERIENCED ENTREPRENEURS INTO THE REGION'S CLEAN ENERGY SECTOR.

THE FELLOWSHIP PROGRAM ADDRESSES A SIMPLE BUT ACUTE PROBLEM: A LACK OF REPEAT ENTREPRENEURS IN THE SECTOR A CRITICAL INGREDIENT IN VENTURE FORMATION, FUNDING, AND GROWTH. THERE ARE A NUMBER OF EXPERIENCED ENTREPRENEURS FROM OTHER SECTORS SUCH AS TELECOM, IT, LIFE SCIENCES, ETC., WITH STRONG INTEREST IN TRANSITIONING INTO THE CLEAN ENERGY SECTOR.
