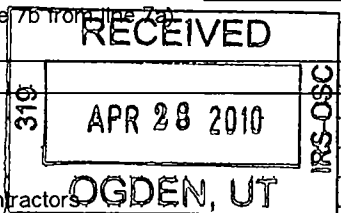



Part III – a: The organization’s achievements in accomplishing its tax exempt purposes during 2009 follows.

1. During 2009, the Corporation coordinated common needs of its two supported charitable organizations in their use of the office building leased by the Corporation. This included items such as maintenance, obtaining necessary insurance, paying utilities, security, property taxes, lease payments, etc. Total program expenses for these activities/expenses was \$61,609 in 2009. Program service revenues in the amount of \$69,000 were received in the form of rents/occupancy payments from the supported organizations.
2. There were no fund raising activities in 2009 and no contributions were received during the year ended 12/31/09.
