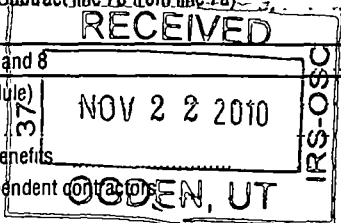

The Foundation awards four scholarships annually to graduating Highland, New Paltz and Marlboro High School students in June at commencement ceremonies. The recipients are chosen by school faculty based on criteria set forth by the Foundation. This criteria is that the student must attain a grade point average of at least 85 or higher, must intend to enroll in a post-secondary or trade school and must clearly demonstrate a commitment to public service and express a desire to pursue a public interest or public service career upon graduation. These scholarships are meant to promote education and encourage young men and women to pursue fields of knowledge or careers that are in the public's best interest, both honoring and perpetuating the Foundation's namesake, who was killed in action while serving in the United States Military.

The Foundation provides funding for youth recreation and educational activities in the town of Highland and surrounding communities in the form of team sponsorship and providing financial assistance to children desiring to participate who may not have the financial means. This program will promote the ideals of teamwork and community exemplified by the Foundation's namesake as a youth sports participant and public servant.

To perpetuate the memory and the spirit of Michael Oremus, who was killed in action in Iraq, while serving in the United States Military, by the encouragement and promotion of charitable, educational and athletic interests, through voluntary grants, by scholarships or otherwise, to individuals, institutions, and organizations located in, but not limited to, the Towns of Lloyd, Marlborough, and New Paltz of Ulster County, New York.
