TRAINING & TECHNICAL ASSISTANCE DELIVERED TRAINING AND TECHNICAL ASSISTANCE TO MORE THAN 100 MENTORING ORGANIZATIONS ACROSS THE STATE THROUGH A SERIES OF DAY-LONG EVENTS AND A TWO-DAY "MENTORING TRACK" AT THE DEPARTMENT OF SOCIAL AND HEALTH SERVICES PREVENTION SUMMIT GRANTS.
