TO PROTECT HUMAN & ANIMAL HEALTH, THROUGH GLOBAL IMPLEMENTATION OF SCIENCE-BASED STANDARDS; TO ENSURE CONSISTENT, AFFORDABLE SOURCES OF SAFE FOOD PRODUCTS EVERYWHERE IN THE WORLD; TO ESTABLISH AN UNINTERRUPTED SUSTAINABLE GLOBAL SUPPLY CHAIN FOR FOOD PRODUCTS TO AND FROM ALL COUNTRIES; AND TO HELP DEVELOPING NATIONS TO INCREASE LOCAL CAPACITY IN THEIR FOOD SYSTEM INFRASTRUCTURES TO FEED THEIR POPULATION, INCREASE STABILITY, PROMOTE ECONOMIC GROWTH, AND STIMULATE EDUCATION.
