**28 SculptureWalk** is an exhibit of 50 outdoor sculptures displayed year-round in downtown Sioux Falls, South Dakota, and an 18 piece indoor sculpture exhibit that is located at Avera McKennan Hospital in Sioux Falls. Artists place their sculptures in the program for one year, and all sculptures are promoted to the public for sale. Artists are eligible to win any one or more of the 14 awards in the best of show, people's choice voting and the random drawings. Awards totalled \$15,000 in 2009. It's estimated that approximately 300,000 people viewed the sculptures during the year.
