

In this start-up phase, Massachusetts Health Decisions, Inc. has elected to compensate the executive director as an independent contractor, not as an employee. As indicated on line 13, the executive director was paid \$56,000 and a 1099-MISC was issued and filed for this compensation. Since he was not paid more than \$100,000 as an independent contractor, was not an employee, and was not compensated as a director / officer of the corporation, this compensation would not have otherwise been reported on this return.

re: Part I, line 20

The only changes in net assets from the beginning to the end of the year are due to changes in the amounts of accounts receivable (sale of Health Care Proxy forms and materials), and fluctuation in our inventories of these materials.

re: Part II, line 24

"Other assets" include current inventories of our education materials and Health Care Proxy forms; an arbitrary valuation of our registered copyrights (3 @ \$5000) in materials which we have sold to hospitals, nursing homes and the public for 19 years in relatively stable quantities; our accounts receivable valued at the end of our fiscal year; and the value of our education program materials and equipment. Even the variable amount of our accounts receivable and our inventory combined does not fluctuate more than \$5000 over time.
