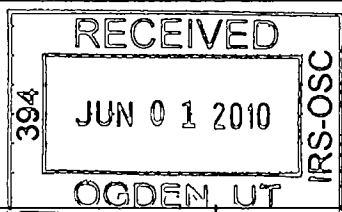

In May, Broken Voices took the story telling concept used in Anthem and created a new platform called BVtv (Broken Voices TV).
