The Foundation granted funds for establishing a student engagement e-mail system to help increase student completion. The e-mail system is used to engage the student pilot throughout their flight training with a series of targeted e-mails and milestones to help promote the completion of student pilot training by providing relevant and timely resources and guidance. The program benefits the pilot community by increasing the percentage of student pilots who follow through the entire flight training program and obtain a pilot certificate. By increasing this completion percentage, it helps improve student pilot satisfaction and engagement later as a member of the pilot community.

4b (Code) (Expenses \$ 500,000 including grants of \$ 500,000) (Revenue \$)

The Foundation granted funds for a live broadcasting of the 2009 AOPA Summit (AOPA Live) to further AFI’s charitable purpose of educating the public and users of the national air transportation system to the value and importance of general aviation to the national air transportation system. AOPA Live was made available to the public, government officials, leaders, etc. who were not able to personally attend the Summit in Tampa, Florida via internet video streaming and was archived for later viewing. The AOPA Live communication vehicle made it possible to share the key discussions related to general aviation without limitations thus increasing the awareness of issues surrounding users of the national air transportation system by educating the public and government officials on the importance of general aviation and general aviation airports.

4c (Code) (Expenses \$ 500,000 including grants of \$ 500,000) (Revenue \$)

The Foundation granted funds for an opinion research study to answer questions from local and federal policy influencers or policy leaders regarding airports. The results enable AOPA to establish effective communications and information programs related to local airport issues throughout the country that influence decision makers responsible for governing airport issues. The program increases the awareness of issues surrounding the users of the national air transportation system by educating the public and government officials on the importance of general aviation and the general aviation airport.
