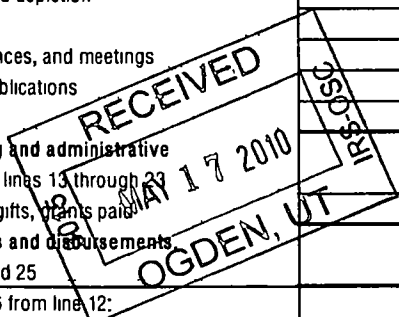

The general policy of The Foundation of Carlo, Inc. ("Foundation") is to allocate funds for charitable, educational, community and religious purposes to support communities in which Carlo, Inc. and its subsidiaries conduct business, primarily to charitable organizations supporting the Roman Catholic Church. Such organization's purpose and continuing work must not be in conflict with the doctrine, policies or practices of the Roman Catholic Church.

Foundation grants are generally not made to individuals, for political purposes, to retire indebtedness, for the payment of interest or taxes, annual campaigns, endowments, emergency funding, to influence legislation or elections, or to private foundations and other grant-making organizations.

Grants are normally made for a one-year period. However, in special circumstances a commitment may be made for support of a project for two or three years and in some specific circumstances on an ongoing basis. The Foundation prefers not to consider more than one proposal from an organization within a twelve-month period. Maximum and minimum grant awards are determined annually by the Board of Directors. The Board of Directors of the Foundation or its grant committee(s) will review each proposal and the Foundation grants may be made for programs that best fit the Foundation's purposes as stated in their Articles.

EVALUATION AND PROCEDURES

All grant recipients must sign and return the "Terms and Conditions of Grant." Any funds not expended for the specific purpose of the grant must be returned to The Foundation of Carlo, Inc. and cannot be diverted to other uses without the express approval of the Foundation.

GUIDELINES FOR PROPOSALS

Proposals must be developed in accordance with the following guidelines and must contain the following:

- a. One-page cover letter typed on the organization's letterhead and signed by an authorized officer of the Board of Directors stating only that the grant request has been approved by the board and indicating the name and phone number of the contact.
- b. A narrative of no more than two typed pages, including the information request in #1-6 below:
 1. Project summary:
 - Goals, objectives, and scope;
 - Need for the project;
 - Start and end dates of the project;
 - Who will be in charge of the project; and expected results.

2. Specific amount requested from the Foundation and the specific use of Foundation funds.
3. Brief statement of the capability of personnel responsible for project implementation.
4. Information on recent grants received by the organization, pending proposals for other funds, and plans for additional funding for this project.
5. Plans for evaluating the success of the grant, including financial accountability.
6. Plans for continuation of the project following the grant period.

c. The following attachments must be provided:

1. If a U.S. charity, proof of IRS 501(c)(3) status, including a written statement from the recipient that such status has not been revoked.
2. If a non-U.S. charity, written determination of the qualified status of the foreign charity under U.S. Tax law as outlined in Revenue Procedure 92-94.
