The New Hampshire Professionals Health Program was developed to work with referred health care professionals for substance use disorders and mental and/or physical illness. Services are available to all licensed medical professionals and residents who practice in NH or seek licensure in NH regardless of their location. In 2009, 39 health care professionals received services including 7 new referral contracts generated by hospital presentations.
