Centennial presentations at the Newark Museum during 2009 told our proud history in moving footage, still photographs and selected objects through the exhibit One Hundred Years Always New, highlighted our collections in 100 Masterpieces of Art Pottery, 1880-1930, From Meiji to Modern Japanese Art Goes Global, 1868-2008, and The Narrative Tradition in African-American Art, presented the shifting nature of contemporary art in Unbounded New Art for a New Century, celebrated the work of contemporary artists in special commissions, Insectia Fantasia by Jennifer Angus, Party Time Imagine America by Yinka Shonibare, and New Work Newark in 3D, a film by Mary Lou and Jerome Bongiorno, reached out to engage and educate audiences with interactive activities in the special science exhibit, Skies Alive Bird Migration in the Garden State, highlighted gifts through the Lore Ross Jewelry Gallery, celebrated artists in Toshiko Takaezu Ceramic Artist and Revelations in Stone The Art of William Edmondson, and, finally, connected with community partners in our presentations of the Newark Teen Arts Annual and the 10th Congressional District Arts Competition

Through its active Education Department the Newark Museum offers a wide range of educational opportunities in the arts and humanities for our diverse audiences indeed, almost 50 percent of visitors experience an educational program Among these were the 34,500 family members who enjoyed drop-in make and take workshops every weekend, as well as lively holiday festivals, from Bug Mania to the Harvest Moon observance A total of 21,000 adults attended public lectures, a significant increase demonstrating the need for facilitated learning Volunteer docent-led public tours served 5,600 The Newark Black Film Festival celebrated its 35th Anniversary as the longest running of its kind to our knowledge, and among the finest, welcoming over 7,000 filmgoers Highlights were A Place out of Time about New Jerseys Bordentown School, and Zina Saro-Wwas This is My Africa With the re-opening of our financial literacy exhibit, Once Upon a Dime, following its national tour of childrens museums, we attracted an additional 46,000 visitors to the Junior Gallery Another 6,000 young people attended Camp Junior Museum, Saturday classes, after-school activities or special Girl and Boy Scouts badge programs Despite the weak economy and restrictions on school travel, the Newark Museum forged new school partnerships that emphasized professional development as well as classroom teaching The museum is known for its ability to develop new and innovative models for preK-12 education programs infused with an interactive, hands-on approach to teaching, inspired by the knowledge that people learn best when they are actively engaged In-depth curriculum support was provided to the Newark Public Schools, New Brunswick Public Schools, Orange Public Schools, St Philips Academy, St Benedicts Preparatory School, Jersey City Public Schools (US DOE 3-year project), and Essex County Vo-Tech The Museum also presented high-quality after school program in the Hillside Public Schools through the state-funded New Jersey After 3 initiative, the only culture-sector provider of after-school services in the state The National Endowment for Humanities awarded the Museum one of three national grants to develop a series of national Picturing America conferences for teachers that connect American art to the teaching of American history and culture Ours was one of only three national grants

The Newark Museum Science Department addresses the need for high quality, inquiry-based science learning The interactive Skies Alive exhibit, developed with the assistance of the New Jersey Audubon Society and the New Jersey Department of Environmental Protection, focused on New Jersey's threatened flyways Members of the Newark Nighthawks, our Science Explorer World Series of Birding team, served as junior docents The Science Explorers program is a major component of the science education program, providing important mentoring and a step up the science career ladder for inner city teens For 15 years, the Newark Museum Explorers program has had tremendous success in mentoring academically gifted students in science and art through internships and research projects Beginning as freshman volunteers and working their way toward becoming almost college level interns, the retention rate of over 600 students in the 15 years of the program has consistently exceeded 95 percent Over the last four years 100 percent of graduating Explorers attended institutions of higher education Other offerings included Dinosaur Day, which attracted a record one-day family audience of over 8,500 visitors, who enjoyed making dinosaur helmets and fossil rubbings During the 100 Hour Centennial Celebration Marathon, our first-ever sleepover hosted 60 kids with the appropriate theme of nocturnal animals The evening started with a pizza party followed by a magic show, live nocturnal animal programs, and a planetarium show The Alice and Leonard Dreyfuss Planetarium, the first in New Jersey, received a prestigious NASA grant of half-a-million dollars, enabling us to convert to a totally digital platform, with a re-opening Asto-Fest set for spring 2010
