




The Foundation received the donation of a home from the estate of a former year round resident of the island. The Foundation in turn sold this home to a qualified resident. The sale include a \$12,000 second mortgage that was to be forgiven provided the individual purchasing the home maintained it as his year round personal residence for a specified period. The specified period was met in 2009 and as a result the above loan was forgiven.

Utilities assistance - Grant to the North Haven Baptist Church to provide assistance to island residents in need of assistance in the payment of their utility bills.
