In 2009, the Foundation completed its PLANS for the expansion of two campus residential homes, part of a multi-year program that will provide enhanced housing options for all Village residents. An apartment in Hudson House was completed, allowing one highly motivated adult greater autonomy and the means towards gaining in independence in day-to-day living skills and self-determination. This addition also created additional openings in the home's bedrooms to allow each resident assigned to the house their own private bedroom. The addition at Susquehanna House, consisting of two bedrooms and one bathroom on the ground floor, provided age-appropriate living spaces for two women. Scholarships and Other Support. One of the ongoing goals of THE FOUNDATION is to raise funds in support of scholarships for those residents OF THE VILLAGE (men, women and children) who require financial aid. The Foundation accomplishes this fundraising through a multi-tiered approach involving special events, publications, support from grantors, and personal inquiries to donors.

Kennedy Willis Center. Throughout the year, THE FOUNDATION sought support for the Village's education and outreach missions by researching, writing and presenting grant proposals to foundations, corporations and individuals with a shared interest in creating opportunities for people who have developmental disabilities. Each day, the school at THE VILLAGE addresses the educational needs of 12 permanent residents and 12 day students, each individual requiring a unique educational plan with the goal of allowing them to reach their fullest potential. Other funding support was used to enhance enrichment opportunities for adult residents in the Village. Funding for outreach and educational programs through the Village's Kennedy-Willis Center on Down Syndrome, an international resource center for up-to-date information on Down syndrome for those outside the immediate area, was also a significant program supported by the Foundation.
