NOTE 7. IMPAIRMENT LOSS

The Organization has a 99.5% ownership in Freedom 1. LP (see Note 12). The investment is accounted for under the equity method and at December 31, 2009 and 2008 is \$384,510 and \$0, respectively. During the year ended December 31, 2009, it was determined that the investment balance required a review for impairment and the actual value was calculated using the discounted value of future cash flows. The impairment loss for the investment amounted to \$761,810.

NOTE 8. RESTRICTED CASH

A cash reserve has been established by the Organization to cover operating deficits and replacement of project assets at the Westgate Manor property. As of December 31, 2009 and 2008, restricted cash amounted to \$19,450 and \$18,888, respectively.
