THE GATEWAY PARK PROJECT IS AN 11-ACRE DEVELOPMENT WHICH FEATURES UP TO ONE MILLION SQUARE FEET OF MIXED-USE SPACE. THE GATEWAY PARK REGION IS CURRENTLY HOME TO NUMEROUS BUSINESSES, OFFICES, RESTAURANTS, BUSINESS SERVICES AND A HOTEL.
