#### Statement 2 - Form 990-EZ, Part III - Organization's Primary Exempt Purpose

#### Description

Arariah Communications was formed to establish and operate a non-commercial educational FM radio station. This station will provide educational and inspirational programming to the Bridgeton/Hopewell area; provide instructional and cultural programming not available on local commercial stations and provide/promote sound moral principles and family enrichment for the community. Local organizations will be provided with ample opportunity to air programming not allowed (because of its noncommercial nature) on local commercial stations.
