Article III - Directors, Paragraph 1(a) - Election, 2nd sentence is deleted and replaced with the following:

~~A skill based process for selecting and re-electing Directors will be utilized.~~ Prospective Directors' ability and desire to dedicate time, talent and support will be evaluated in selecting and re-electing Directors.

*Reason for Change: this statement outlines more clearly the criteria for selecting a board member. Although an individual may not have a business background, they may be connected with people with the means to donate to NEH.*

Article III - Directors, Paragraph 1(a) - Election, 6th sentence is deleted and replaced with the following:

~~The Vice President/Executive Director of the Corporation shall serve as an ex-officio Director of the Board with a vote.~~

The following persons, subject to Board and Member approval, shall serve as ex officio directors, each with a vote:

- (i) The Vice President / Executive Director of the Corporation;
- (ii) The Presidents of the Auxiliary of Albany Memorial Hospital and Samaritan Hospital;
- (iii) and the Presidents of the Albany Memorial and Samaritan Hospitals Schools of Nursing Alumni Association.

A person serving in more than one such office shall have only one vote on The Board.

*Reason for Change: Addition of key positions to enhance board membership and relationships with the Auxiliaries and Schools of Nursing.*

Article III - Directors, Paragraph 1(b) - Term, is modified as follows:

The time a Director serves filling the remainder of the term of a vacant Directorship shall ~~not~~ be counted in calculating the number of terms or years a Director has served for purposes of this section, if greater than two years.

*Reason for Change:* this change is consistent with the NEH and affiliate corporations (amended 9/07).

---

Article III - Directors, Paragraph 5 - Vacancies

A Director elected to fill a vacancy shall serve the remainder of the term of the vacant Directorship. ~~This time will not count in calculating the number of terms or years the Director has served for purposes of Paragraph 1(b) of this Article.~~ Such time, if greater than two years, will count in calculating the number of terms the Director has served for purposes of Paragraph 1(b) of this Article.

*Reason for Change:* this change is consistent with NEH and affiliate corporations (amended 9/07).

---

Article III - Directors, Paragraph 12. Contracts and Services is deleted and Paragraphs 13-15 are renumbered to 12-14.

*Reason for Change:* content is included in Article XVI - Transactions with Directors and Officers. See Robert Swidler memo, attached.

---

Article IV - Officers, Paragraph 8. Treasurer is modified as follows:

8. Treasurer. The Treasurer shall either personally perform, or ensure that appropriate officers of the Corporation perform the following functions: have the custody of all funds, property, and securities of the Corporation, subject to such regulations as may be imposed by The Board. He may be required to give bond for the faithful performance of his duties, in such sum and with such sureties as The Board may require. When necessary or proper he may endorse on behalf of the Corporation for collection checks, notes, and other obligations, and shall deposit the same to the credit of the Corporation at such bank or banks or depository as The Board may designate. He shall make such payments as may be necessary or proper to be made on behalf of the Corporation. He shall cause the books of the Corporation to be kept for the purpose of full and accurate account of all moneys and obligations received and paid or incurred for or on account of the Corporation, and he shall exhibit such books at all reasonable times to any Director on application at the offices of the Corporation. He shall, in general, perform all the duties incident to the office of Treasurer, subject to the control of The Board.

*Reason for Change:* this change is consistent with NEH and affiliate corporations (amended 9/08) and clarifies that such duties may be performed by the CFO or other officer of the Corporation, which is in line with how NEH currently operates.

---

Article VI - Committees is renumbered as Article VII - Committees.

*Reason for Change:* misnumbering error. Note: subsequent articles are numbered properly.-

---

Article VI - Committees, Paragraph 6 - Northeast Health Committees is deleted and Paragraph 7 - Compensation is renumbered as Paragraph 6.

*Reason for Change:* Northeast Health “integrating” committees no longer exist.

---

Article XVI - Transactions with Directors and Officers, Paragraph 2. Interested Directors and Officers is amended as follows:

(a) Each Director and officer shall submit in writing, on a form provided by the Corporation to the Chairperson a list of all business or other organizations of which he is an officer, member, owner or employee or for which he acts as an agent, with which the Corporation has, or might reasonably in the future enter into, a relationship or a transaction. Each written statement will be resubmitted annually, with any necessary changes, and updated as Directors engage in new potentially conflicting activities or become aware of additional potential conflicts prior to the first regular meeting of each year.

(b) If a matter comes before the Board in such a way as to give rise to a potential conflict of interest, the affected Director shall make known the potential conflict, whether disclosed by his written statement or not, and after stating his position on the matter and answering any questions that might be asked of him, shall withdraw from the meeting for so long as the matter shall continue under discussion. If the matter is brought to a vote, the affected Director shall not vote on it. If he fails to withdraw voluntarily, the Chairperson of the Board is empowered to require that he remove himself from the room during both the discussion and vote on the matter. If the conflict of interest affects the Chairperson, the Vice-Chairperson is empowered to require that the Chairperson remove himself in the same manner, and for the duration of discussion and action on the matter, the Vice-Chairperson shall preside.

(c) If the matter is the item of business for which a special meeting of the Board is called, the affected Director shall not be counted to establish a quorum, nor shall he participate in the deliberations or vote on the matter.

(d) ~~If a Director fails to make known a potential conflict and the Board takes an action on the matter, that action will not be void or voidable if (i) the action was taken in good faith by a sufficient number of affirmative votes of directors without a conflict or (ii) the action was fair to the Corporation at the time it was taken by the Board.~~ If the Board or committee has reasonable cause to believe that a Director has failed to disclose an actual or possible conflict of interest, then the Board or committee shall consider whether another discussion and/or vote on the matter is necessary or appropriate, and management shall refrain to the extent practical from

acting on the basis of the initial Board or committee action until such reconsideration has occurred.

*Reason for Change. Wording is being amended for consistency with the NEH bylaws, as recommended by the Corporate Compliance & Audit Committee in 2005.*
