Since its inception in 1981 NJCASA has acted as an advocate for survivors and their loved ones as well as the individuals and agencies that support them. NJCASA provides information and education to the public, media and government officials regarding sexual violence issues and advocates for policies, procedures, and programs that are survivor-centered. NJCASA works with the Sexual Violence Programs to help build and sustain their capacity to provide core services to survivors and their loved ones, work with community coalitions to implement primary prevention strategies, raise awareness of sexual violence, and develop best practices overall.
