

**Program Services**

**4a**

***Student Travel and Achievement Awards***

An active Students and New Researchers Committee organizes special recognition at the ISES annual meeting for student abstracts and promotes interaction with peers and mentors during the conference and through the internet throughout the year. Sixty-six students (18.6% of participants) attended the 2009 annual conference. ISES provided \$20,350 in travel awards to students attending the conference and presenting their scientific work through posters. A poster competition for students also provided \$950 in cash awards for the most outstanding poster presentations.

***Messaging***

ISES hired a professional organization in FY09 to develop standard messaging and proof points to more clearly and effectively describe exposure science and help advance it. These were developed for use by the broader exposure science community in grant applications and other communications about their research in exposure science. ISES paid this organization \$19,750 in FY 09. The ISES Strategic Planning Committee is developing an action plan for disseminating these messages to policy makers and decision makers to inform them about the value of exposure science and the important of including exposure science in their work.

***Web Site***

The ISES web site may be accessed by any interested party. A new website with new design and expanded content was introduced in 2009. The web site contains information about the history and organization of the society, e.g., officers and councilors, committees, by-laws, the current Society conference; employment opportunities, other events of interest, Society awards, a section for students and new researchers, and special sections devoted to the Society's Distinguished Lecturer Program and Exposure Science Glossary. The glossary is provided as a service to the scientific community. The web site also includes externally hosted password-protected pages available to current members only, providing electronic access to the Society journal and a

searchable membership directory, and allowing members to join or renew their memberships and pay dues online through a secure credit card processor.

#### **4d – other program services.**

##### ***Official Journal***

**Expenses: \$12,155 including 0 Grants Revenue \$62581**

The official journal of the ISES is the *Journal of Exposure Science and Environmental Epidemiology*. All members receive a one-year subscription to this bi-monthly, peer-reviewed journal for each year of membership. Members of the Society maintain editorial control of the journal. The Editor-in-Chief and Associate Editors for Reviews are Society members. The Society pays the journal publisher, Nature Publishing Group, a per-copy cost for each issue mailed to members. There is no difference in the cost for providing the issue to members inside or outside the U.S. The Society paid the journal publisher \$13.00 per copy for all 2009 issues. A total of 2,288 copies of these issues were mailed to members.

Special journal issues – ISES may solicit funding for publication of additional issues on special topics or to ensure timely publication of accepted material. In 2009 an additional issue, funded by the American Chemistry Council, was published in February and mailed to all members to ensure timely publication of accepted peer-reviewed articles. The funding from the American Chemistry Council covered the cost to provide this issue to members.

##### ***Annual Conference***

**Expenses: 0 Revenue: \$37268**

ISES holds an annual conference each year. Most annual conferences are held in the United States, but approximately every 3 to 4 years a meeting is held outside North America to provide access for the international membership. The annual meeting is also held jointly with the International Society for Environmental Epidemiology every 2 or 3 years. The annual meeting brings together scientists from throughout the world to exchange ideas and methods for research in exposure analysis. It provides a forum for communicating current epidemiologic research, facilitates international collaboration in research and training, and highlights emerging global environmental health issues. Awards are made for best student papers. There were 355 participants from the US and other countries at the 2009 annual meeting, which was held in Minneapolis, MN, November 1-5, 2009. The theme of the meeting was Transforming Exposure Science in the 21<sup>st</sup> Century.

##### ***25<sup>th</sup> Anniversary Project: Exposure Digests***

**Expenses: \$4,453 including 0 Grants Revenue 0**

--- In August 2009, the Society and the publisher and editor-in-chief of the society journal, in recognition of ISES's 25<sup>th</sup> year, initiated an endeavor to recognize historic successes of exposure science and its contributions to understanding environmental exposures, improving public health, advancing risk management, informing other related disciplines, and impacting policy. Members were invited to nominate topics and authors for a series of short mini-review papers, called Exposure Digests, for publication in the journal. A selection committee including the journal editor-in-chief and editorial board members evaluated the nominations and selected and invited

the authors and topics. All manuscripts were subjected to peer review. ISES hired a consultant, an exposure scientist, to assist with this project, including participating on the selection committee and liaising between the authors and the editorial board, managing development and completion of each mini-review. ISES paid the consultant a total of \$4,452.50 in FY 2009. The Exposure Digests will be published in 2010 issues, and the selection committee, with the assistance of the ISES Strategic Planning Committee, is developing a communications plan surrounding these mini-reviews.

***Scientific Achievement Awards Program***

**Expenses: \$3,682 including 0 Grants Revenue 0**

ISES recognizes outstanding scientists with four awards. Most of these awarded annually. The ISES Awards Committee publicizes the awards through the society website, email, and other channels, reviews and selects the awardees, and administers the awards. The Jerome J. Wesolowski Award recognizes outstanding contributions to the knowledge and practice of human exposure assessment. The awardee receives \$2500 and presents the Wesolowski Lecture at the ISES annual conference. The Joan M. Daisey Outstanding Young Scientist Award recognizes outstanding contributions to the science of human exposure analysis by a young scientist. The awardee receives ISES membership for one year and \$1000. The Constance L. Mehlman Award recognizes outstanding contributions in exposure analysis research that helped shape a national or state policy or that provided new approaches for reduction or prevention of exposures. This award is presented every other year or less frequently, based on nominations received. The awardee receives \$2000. The CDGUV/BGFA Award for Young Exposure Scientists fosters research in exposure areas with linkages to biomonitoring for superior doctoral students working on their dissertation or superior first-year postdoctoral exposure scientists. This award, provided by the DGUV\* Research Institute of Occupational Medicine (BGFA) in Germany, is administered by ISES. The awardee receives 1500 Euros and may be invited to give a talk in Europe on his/her research. Nominations for each of these awards are solicited annually from the membership, and the awards are presented at the annual ISES conference.

***Distinguished Lecturer Program***

**Expenses: \$0 Revenue 0**

The ISES Distinguished Lecturer Program was developed to stimulate interest and enhance recognition of exposure analysis science. The program makes outstanding speakers in the science of exposure analysis available to qualifying institutions and organizations. The ISES sponsors the travel of the Distinguished Lecturers as needed. In FY 2009, there were no expenses for this program, as the Distinguished Lecturers performed their work pro bono.


