An interested person may, after disclosing a known conflict, disqualify him or herself from further participation in discussions or determinations regarding the transaction or arrangement, or may seek the guidance of the Board or Committee. In such cases, the interested person may be asked to leave the Board or committee meeting while the actual or apparent conflict is discussed and voted upon. The remaining Board or committee members shall decide if a conflict of interest exists. ADDRESSING THE CONFLICT OF INTEREST. (1) The Chairperson of the Board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement. (2) After exercising due diligence, the Board or committee shall determine whether the Corporation can obtain a more advantageous transaction or arrangement with reasonable efforts from a person or entity that would not give rise to a conflict of interest. (3) If a more advantageous transaction or arrangement is not reasonably attainable under circumstances that would not give rise to a conflict of interest, the Board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Corporation's best interest and for its own benefit and whether the transaction is fair and reasonable to the Corporation and shall make its decision as to whether to enter into the transaction or arrangement in conformity with such determination. VIOLATIONS OF CONFLICT. (1) If the Board or committee has reasonable cause to believe that a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose. (2) If, after hearing the response of the member and making such further investigation as may be warranted in the circumstances, the Board or committee determines that the member has, in fact, failed to disclose an actual or possible conflict of interest, it shall take appropriate corrective action as determined by the Board, with respect to the Director and the transaction or arrangement. RECORDS OF PROCEEDINGS. The minutes of the Board and all committees with Board-delegated powers shall contain: (a) the names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the Board's or committee's decision as to whether a conflict of interest, in fact, existed, and (b) the names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement, and a record of any votes taken in connection therewith. COMPENSATION COMMITTEE. (a) A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Corporation for services is precluded from voting on matters pertaining to that member's compensation. (b) Physicians who receive compensation, directly or indirectly, from the Corporation or any affiliate, whether as employees or independent contractors, are precluded from membership on any committee whose jurisdiction includes physician compensation matters. ANNUAL STATEMENTS. Each director, principal officer and member of a committee with Board-delegated powers shall annually sign a statement which affirms that such person: (a) has received a copy of the conflicts of interest policy and the Corporation's By-Laws, (b) has read and understands those provisions, (c) has agreed to comply with those provisions, and (d) understands that the Corporation is a charitable organization and that in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax exempt purposes. PERIODIC REVIEW. To ensure that the Corporation operates in a manner consistent with its charitable purposes and that it does not engage in activities that could jeopardize its status as an organization exempt from federal income tax, periodic reviews shall be conducted. USE OF OUTSIDE EXPERTS. In conducting the periodic reviews provided for in Section 7 of this policy, the Corporation may, but need not, use outside advisors. If outside experts are used, their use shall not relieve the Board of its responsibility for ensuring that periodic reviews are conducted. LOANS. No loans, other than through the purchase of bonds, debentures, or similar obligations of the type customarily sold in public offerings, or through the ordinary deposit of funds in a bank, shall be made by the Corporation to its directors or officers, or to any other corporation, firm, association or other entity in which one or more of its directors or officers are directors or officers or hold a substantial financial interest, except a loan to another Type B not-for-profit corporation.
