GEORGE BASS MEMORIAL DANCE SCHOLARSHIP

One full dance scholarship may be granted each full week session to a new folk dancer to honor the memory of George Bass, a long-time friend of Mainewoods. Travel expenses are not included. Qualifications are:

- (1) Applicant has been folk dancing for at least 1 year
- (2) Applicant demonstrates an interest in folk dance, folk music and/or folk culture
- (3) Applicant provides a letter of reference from a leader of a group with whom he/she dances
- (4) Applicant plans to share dances learned at Mainewoods with his/her own dance group

Applicants should send a letter of application that includes a brief background, why he/she wants to attend camp, and what use he/she will make of the experience.

In 2009 three George Bass Memorial Dance Scholarships were granted. The value of this scholarship was \$ 521.23 (including ME Sales Tax) for a total value of \$ 1563.72.
