The Marietta Police Athletic League (MPAL) co-hosted the first annual Youth & Law Enforcement Symposium with
the purpose of bridging relationships between area youth and law enforcement. MPAL's involvement in / sponsorship of
the 6th Grade Basketball Program, summer swim lessons, tutoring program, and YELLS Mentoring Program continued
in 2009. In addition, MPAL paid for martial arts and ballet lessons for area youth. New programs for 2009 were the Family
Stability Program (area families participated and received a nominal stipend when goals were reached), the Early Learning
Initiative (to increase school readiness and long term success for preschool children of the Franklin Road community
in Marietta, GA), and Summers Kool Camp (summer camp). Community outreach and recreational activities in 2009
included golf, bowling, Back to School Bash (providing area youth with free backpacks and school supplies), Holidays
Around the World (providing hoiday gifts to area youth), Teen Night and Movie Night.
