Summer Day Camp - Each summer our YMCA provides two high quality summer day camps for youth ages 5 to 14 years. It is one of our highest attended programs over the years. The main goal of the YMCA Day camp is to provide a safe and happy environment as we strive to achieve the camp objectives. We do this by giving our campers a great opportunity to meet new friends and have a positive experience to last a lifetime.

Our Original camp has been offered for over 25 years and we were able to open a second site in 2006. Our first year we offered 3 weeks of camp, our second year we offered 5 and in 2008 we were able to offer 9 full weeks of camp. The 5-day per week programs, offered our families a choice of 5, 3 or 2 days per week depending on their need. These options along with a choice in location provided assistance for those families using the program as a day care. Our programs helped to relieve the burden of balancing work and family and made it possible for the parents or our children to remain gainfully employed, knowing their children were thriving in a safe, developmentally sound environment.

Our service has high incidence of low-income families and many of our campers apply for and receive help from our financial assistance program for their camp fees and membership dues. We provided membership and camp financial assistance to many of our campers. 165 participants were served.

After School Program - Our YMCA started an After School Program to serve the children in the Wallenpaupack Area in the fall of 2007. It was offered to help parents with childcare during the after school hours when they are still at work. Some of the children also participate just to have a positive experience with our program. We offer homework assistance, crafts, games, and group work. The program was expanded in 2008 and we started the process of licensing the program with the state. We still continue the process of getting the program licensed. We collaborate with the Hawley Public Library and they provide a Youth Librarian to our site one day per week to provide literary education. 23 participants were served in this program.

Along with our Golden Girls fitness class we have started the Silver Sneakers fitness program to serve our senior population. Both of these programs continued to grow and change with the participants needs. We wanted to give them the opportunity to find a healthier lifestyle with exercise, stretching and strength training. What they also found was a caring group of friends who look out for and care for one another. For the teenagers, through adult age, we started a Boot Camp class that gives a more challenging workout. This enabled us to target another age group in our community. Our Pre school sports program is still very strong and is designed to give pre school age children the opportunity to experience sports in a non-competitive, learning environment. They develop small and large motor skills and learn activities they can participate in for life. Their parents are also finding that the children that attend this have better experiences in school when playing active games, while in gym class or out on the playground. helmets if needed. We also educate the family members that bring them to the event. Our group also works with Safe Kids and provides car seat safety check ups at local car dealerships. This is a wonderful collaboration of non profits working together to provide services to our local families.
