		HISTORY MARY'S SHELTER OPENED IN 1995 AND IS LICENSED BY THE STATE OF PENNSYLVANIA AS A MATERNITY HOME AND A PRIVATE CHILDREN AND YOUTH SOCIAL SERVICE AGENCY, WHICH SERVES THE NEEDS OF HOMELESS, PREGNANT YOUNG WOMEN. MANY OF THE RESIDENTS HAVE MULTIPLE HOME LIFE PROBLEMS WITH LITTLE OR NO SUPPORT FOR THE PRESENT PREGNANCY. ALTHOUGH THERE ARE MANY OUTPATIENT OR CLINIC SETTINGS IN THE COMMUNITY THAT OFFER PRENATAL CARE, MARY'S SHELTER IS THE ONLY RESIDENTIAL FACILITY SPECIFICALLY FOR PREGNANT WOMEN. OVER 285 YOUNG WOMEN HAVE BEEN RESIDENTS AT MARY'S SHELTER. THE MISSION OF MARY'S SHELTER IS TO PROVIDE ADEQUATE HOUSING AND PRIMARY CARE WHERE EACH RESIDENT IS OFFERED LIFE-CHANGING ASSISTANCE THROUGH QUALITY, COMPREHENSIVE CARE IN A SECURE, COMFORTABLE, AND SUPPORTIVE ENVIRONMENT. THE BOARD OF DIRECTORS IS THE GOVERNING BODY OF MARY'S SHELTER. THEIR PRIMARY OBJECTIVES ARE TO IMPLEMENT PROGRAM AND ORGANIZATIONAL POLICIES, UPHOLD THE MISSION AND PHILOSOPHY, AND PROVIDE VISION AND DIRECTION FOR FUTURE GROWTH. THE STAFF OF MARY'S SHELTER MANAGES THE DAY-TO-DAY OPERATIONS AND PROVIDES DIRECT CARE AND SERVICES TO THE YOUNG WOMEN WHO RESIDE AT THE FACILITIES. THE VOLUNTEERS ACTIVELY SUPPORT CURRENT PROJECTS INCLUDING FUNDRAISING, CLIENT ACTIVITIES, OR IMPROVING THE FACILITIES. VOLUNTEER SUPPORT IS A VITAL COMPONENT TO THE PROGRAM AND SERVICES PROGRAM SERVICES WHAT MAKES THE PROGRAM UNIQUE IS THE FOCUS ON COMPREHENSIVE SERVICES. UPON ENTERING THE PROGRAM AT MARY'S SHELTER AND MARY'S HOME, THE CASE MANAGER, COUNSELOR, AND RESIDENT ESTABLISH LONG-TERM AND SHORT-TERM GOALS. THE PRIMARY AREAS OF FOCUS ARE PRENATAL CARE AND PARENTING SKILLS, PERSONAL COUNSELING, EDUCATION, AND FUTURE HOUSING WITH THE AIM OF ACHIEVING INDEPENDENT LIVING SKILLS, THE RESIDENT, CASE MANAGER, AND COUNSELOR DEVELOP A PLAN OF ACTION WITH ATTAINABLE GOALS. THESE GOALS ARE REVIEWED AND UPDATED WITH THE RESIDENTS ON A REGULAR BASIS. GOALS ARE WRITTEN WITH ASSOCIATED MEASURABLE TASKS. RESIDENTS ARE GIVEN A TIMETABLE FOR COMPLETION AND EVALUATION ANALYSIS. THE YOUNG WOMEN WHO SEEK HOUSING AND SUPPORTIVE SERVICES FROM MARY'S SHELTER ARE EXPERIENCING MULTIPLE PERSONAL LIFE PROBLEMS AND OBSTACLES THAT HINDER THEIR PROGRESS TOWARD INDEPENDENCE. THE CASE MANAGEMENT SERVICES FOCUS PRIMARILY ON ASSISTING THE CLIENTS WITH THE TASKS RELATED TO COMPLETING GOALS AND OBJECTIVES WITH REGARDS TO THE PREGNANCY, EDUCATION, AND HOUSING, THEREBY ADDRESSING THE ISSUES OF HOMELESSNESS, LOW PAY, AND LOW ACHIEVEMENT. THE COUNSELING SERVICES FOCUS ON ASSISTING THE CLIENTS WITH INTERNAL OBSTACLES TO SUCCESS SUCH AS LOW SELF-ESTEEM, LOW EXPECTATIONS, ANXIETY, DEPRESSION, AND MANAGEMENT OF MENTAL HEALTH DISORDERS. ACCOMPLISHMENTS OVER A FIFTEEN YEAR HISTORY, MARY'S SHELTER HAS DEMONSTRATED THAT THE SUPPORTIVE SERVICES AND HOUSING PROVIDED BY THE ORGANIZATION CAN CHANGE LIVES. IN 2000, MARY'S SHELTER EXPANDED ITS SERVICES TO INCLUDE A SECOND HOUSING FACILITY. MARY'S HOME IS A TRANSITIONAL HOUSING PROGRAM THAT PROVIDES AN ADDITIONAL ONE TO TWO YEARS OF SUPPORTIVE SERVICES FOR THE YOUNG WOMEN ENROLLED IN EDUCATIONAL OR JOB TRAINING PROGRAMS. IN 2001, SIX CLIENTS WERE ENROLLED IN HIGH SCHOOL WITH FOUR GRADUATING AND TWO SUCCESSFULLY PROGRESSING TO THE NEXT GRADE. IN 2002, TEN YOUNG WOMEN COMPLETED THEIR GED STUDIES AND FOUR CONTINUED ON TO COLLEGE. FROM 2003 TO 2005, THE AGENCY CONTINUED TO EXPERIENCE THE SAME HIGH NUMBER OF EDUCATIONAL SUCCESSES INCLUDING YOUNG WOMEN WHO GRADUATED FROM CERTIFIED NURSING ASSISTANCE PROGRAMS, MEDICAL TECHNICAL ASSISTANCE PROGRAMS, AND SECRETARIAL PROGRAMS. SEVERAL RESIDENTS MAINTAINED PART-TIME EMPLOYMENT WHILE CONTINUING THEIR EDUCATION. IN 2006, TWO FORMER RESIDENTS GRADUATED FROM COLLEGE WITH FOUR-YEAR DEGREES. MARY'S SHELTER PROVIDES THE SOLID FOUNDATION AND THE OPPORTUNITY FOR YOUNG WOMEN TO CHANGE THEIR FUTURE. IN 2008, TWO MORE FORMER RESIDENTS GRADUATED FROM COLLEGE WITH BACHELOR'S DEGREES IN NURSING. IN 2009, FIVE RESIDENTS COMPLETED THE CERTIFIED NURSING ASSISTANT TRAINING.
