**Line 10: We had one major contributor, Mrs. Elaine Kligerman, who contributed \$100,790 as shares of common stock.**

**Line 17a: We feel that circumstances this year still warrant our remaining as a publically supported organization.**

**First, even though we have dropped a bit to 23% this year, this is still not so far below 33%. Second, our Public contributions fell this year by \$7,500 because of the economy. Except for that we were expecting a significant increase. Third, our single, major donor is never certain. Were she to fail to support us this year, we would most likely be back at the 33% threshold.**
