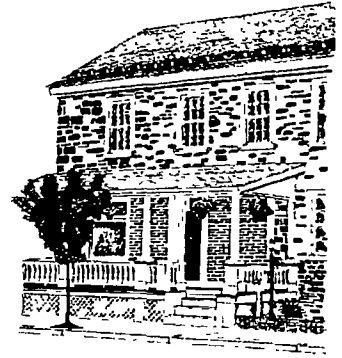

NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities

Women's 5K Classic is an organization established with the goal of raising funds to be donated to local hospitals and universities for the benefit of breast cancer research. There are no specific restrictions placed on any contributions by the donors. The Organization runs a 5K race in which funds raised by participant fees and sponsors are distributed to local breast cancer research institutions based on recommendations of a funds distribution committee.

Basis of Accounting

The Organization's policy is to prepare its financial statements on the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Under this basis, which it uses for its tax reporting, revenues are recognized when received rather than when earned, and expenditures are recognized when paid rather than when incurred.

Credit Risks

The Organization maintains their cash accounts in several depository accounts which, at times, may exceed federally insured limits. The Organization has not experienced losses in such accounts. The Organization believes they are not exposed to significant credit risk.

The Organization maintains a significant portion of its assets in investments, which are subject to fluctuations in value. Further, the Organization is subject to risks associated with each investment, such as compliance of the issuer with certain contractual obligations. The Organization minimizes concentrations of risk by hiring professionals to manage investments and by diversifying the holdings in its investment portfolio.

NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates

The preparation of financial statements on the cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Recognition of Income from Investments

Income from investments is recognized on the cash basis. Security transactions, if applicable, are accounted for on a trade date basis.

Capitalization and Depreciation

Fixed assets are recorded at cost. Depreciation is provided based on the Modified Accelerated Cost Recovery System over the estimated useful lives of the related assets (five years).

Accounting for Long-Lived Assets

The Organization reviews long-lived assets, certain identifiable assets and any goodwill related to those assets for impairment whenever circumstances and situations change such that there is an indication that the carrying amounts may not be recoverable. At December 31, 2009 and 2008, respectively, the Organization believes that there has been no impairment of its long-lived assets.
