Continuing Legal Education - Roughly 50 hours of continuing legal education classes are provided annually at a nominal charge to Pennsylvania licensed attorneys, and at a reduced rate to members These CLE classes are intended primarily as a membership benefit rather than as an important source of revenue The revenue generated by this benefit is substantially offset by the costs of publication, publicity, food, and registration fees paid to the Pennsylvania CLE Board

Pro Bono Programs - The association's extensive pro bono programs do not generate any revenue for the Dauphin County Bar Association The association provides legal services to roughly 500 clients annually, who are screened for eligibility by the Harrisburg Office of MidPenn Legal Services Additionally, the association's pro se custody and divorce clinics assist roughly 150 clients each year The cost of providing these services consists primarily of the salary (45%) paid to our pro bono and public services coordinator

Lawyer Referral Program - Dauphin County Bar Association's lawyer referral program assists roughly 3,000 clients (out of 5,000 who call for assistance) find an attorney appropriate to their legal needs The only fees charged by the association are the lawyers' registration fee (\$95) to participate in this service The revenue generated by the registration fees (approximately \$10,000) is more than offset by the costs of malpractice insurance and the salary (55%) paid to our pro bono and public services coordinator This program is intended primarily as a community service, rather than an important source of revenue
