St Patrick Hospital and Health Science Center is undergoing construction to its Emergency Department (ED) This department covers a geographical area covering western Montana and northern Idaho The ED is the region's leader when it comes to providing critical care, collaborating with emergency care teams from as far away as Sheridan, Montana and Salmon, Idaho The hospital is the only Level II Trauma Center, Accredited Stroke Center and Accredited Chest Pain Center in the region The ED is equipped with a full language interpreter service and a team of case managers and clinical social workers to assure the details of your ED stay, hospital admission or transfer are taken care of The hospital is undergoing this redesign to develop our capabilities so we can better serve our community and region in the future The redesign will allow our ED to expand to support patient population growth, include critical technology, increase patient privacy and improve ED access, speed and safety The Foundation seeks gifts to support over \$10 million of free care provided at the hospital every year We also develop funds to invest in new equipment and facilities, fund clinical and basic research and support rural health care facilities and providers in western Montana Our fundraising efforts benefit St Patrick Hospital, Montana Cancer Center, St Joseph Medical Center, St Patrick House and The International Heart Institute

The foundation is instrumental in developing the Montana Cardiology Telemedicine Network (MCTN) The telemedicine infrastructure provides patients and professionals with real-time access to cardiologists located miles away at the International Heart Institute, a division of St Patrnck Hospital and Health Sciences Center The network uses advanced technology to improve healthcare in rural physician offices, hospitals and tribal clinics throughout western Montana The Foundation received a three-year grant from HRSA - the Office for Advancement of Telemedicine (OAT) to finance a study of the efficacy and efficiency of telemedicine in the provision of home health care The Grant funds telemedicine equipment for a consortium of home care providers in western Montana and funds the collection and analysis of data related to clinical and financial performance of use in very rural environments
