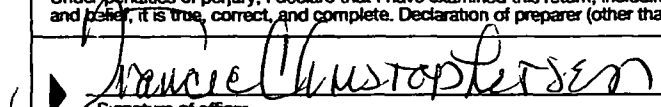
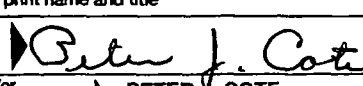

Line 4 Scholarship
