In late 2008 The Congregational Home purchased approximately 4.25 acres of contiguous real property in the middle of its campus with the plan of demolishing the buildings and converting the site into an integral part of resident life. The major focus of the Foundation throughout 2009 was conducting a capital campaign to assist the Home in retiring the property acquisition indebtedness.
