The Foundation makes grants and distributions from these funds, conducts site visits, consults with local organizations, conducts needs assessments and works with donors to establish priority areas of need for a variety of causes including health care, education, youth and families, the arts, emergency preparedness, pet care, women fleeing domestic abuse, the disabled and seniors.

The Foundation also actively raises money to provide fast turnaround financial support to a variety of local charities through its Circle of Giving program. Grants from the Circle of Giving may be used for operations or specific program needs, providing critical support to classroom teachers, families in need of food and clothing, children struggling in school, recreational opportunities for low-income and disabled children, scholarships to people returning to work, at-risk infants, first-time mothers, and the arts.
