Local agencies go through a rigorous review process including written proposal with budget and presentation. 40-50 volunteers from our community make the final decisions. Donor Option Funds include donations designated through UWENM and ENMCFC. Costs involved are related to the recruitment, training and support of the volunteers for the review process and training, communication, and oversight of agencies applying for and receiving funds.

In Addition, grants we made to organizations participating in a collaborative program to recycle household appliances and fixtures from the demolition of a housing development-Operation Reclamation.

Community Building Activities: United Way staff and volunteers participate, plan, lead and support various events and activities in our communities in conjunction and collaboration with many other non-profits and government agencies. These activities promote healthy lifestyle choices for our citizens and address issues within our community.
In addition, Zenith Youth Leadership Academy, an 8 month facilitated leadership program for 7th & 8th graders was implemented.
Plus the Day of Caring project for 2009 was to build safe, age appropriate play space for space for a low-income neighborhood with young children. This volunteer effort successfully purchased playground structure, removed unsafe existing equipment, installed new playground and landscaping all with work of 70+ volunteers.

2-1-1 Information and Helpline for residents of Curry & Roosevelt Counties. In addition, through a generous donation, heaters were supplied to 14 families without heat in their homes.
