The Kennebec Historical Society promotes the study of the history of Kennebec County by forming and preserving historical collections of appropriate materials, making these collections available to the public, providing research assistance to the public, and presenting public educational programs.

The Society accepted more than 2,000 items donated by approximately 180 people in 2009. The Society also completed installation of a climate-controlled archive to preserve rare documents. Volunteers provided research assistance to approximately 50 members of the public interested in local genealogy, the history of historic buildings in the area, major historical events, and other local history topics. The Society provides the public with a searchable database of its collections, available during public hours or by appointment. This program is run entirely by local volunteers.

4b (Code: **519120**) (Expenses \$ **10,344.** including grants of \$ **0**) (Revenue \$ **10,344.**)**Educational presentations for the public. The Society presented 12 monthly programs open to the public in various locations throughout the county on a wide range of local history topics.**

More than 400 people attended presentations in 2009. The Society also mounted quarterly public exhibits from its collections at its headquarters in the historic Fuller-Johnson-Fisher House, an 1830's structure within one of Augusta's historic neighborhoods. Approximately 200 people visited the house in 2009. The Society published a bi-monthly newsletter with descriptions of additions to the historical collections, public presentations and exhibits, as well as news about the activities of other local historical societies and libraries in the county. The newsletter is available free to visitors at the Fuller-Johnson-Fisher House and is also mailed or sent via e-mail to approximately 450 members. The Society's website also provides free access to a Kennebec County surname database for members of the public searching for people who have resided in Kennebec county. This program is also run entirely by volunteers.
