The North American Association for Environmental Education (NAAEE) conducted a major portion of the U S Environmental Protection Agency National Training Project, which has been known for over a decade as the Environmental Education and Training Partnership (EETAP) As a part of that program we provided the web portal for Environmental Education on the Internet (EE-Link), non-formal certification, ongoing work with the national Guidelines for Excellence in Environmental Education, participated in the National Council for the Accreditation of Teacher Education (NCATE), and assisted state and regional environmental education associations with professional development and capacity building NAAEE also held the world's largest annual conference for environmental education for the purpose or professional development NAAEE also formed a partnership with the National Oceanic and Atmospheric Administration (NOAA) and is continuing to build on the baseline set in earlier years to measure middle school environmental literacy
