Food For Work program AMURT distributed food in Haiti to workers who are improving the infrastructure of the Anse-Rouge region (building or rehabilitating roads, repairing gullies, etc), this amounted to approximately \$1 million worth of food products provided by the World Food Programme or Programme Alimentaire Mondial in the year ended December 31, 2009 Other projects in Haiti include agricultural development - distribution of seedlings and fertilizers, providing training, reforestation of watersheds, etc Haiti health care program - built one new health center and rehabilitated two others This provides health treatment to the population of the surrounding areas at reduced cost Education - Built a new school and is training children in ecology, sports fairness, health awareness, and social activism The children are also encouraged to participate in the development process and have helped with tree planting and water filtration Salt production - AMURT has created jobs to construct crystallizers and install infrastructure for salt production and depots for storage These workers too obtain food from the Food For Work program The nature and level of relief and support efforts in Haiti changed dramatically in January 2010 with the tremendous earthquake, but the above programs were AMURT's focus in 2009

Community Empowerment through Skill Training & Income Generation Activities AMURT is caring for 3000 children either fully or partially orphaned by HIV/AIDS in 9 project areas in Kenya Our aim is to provide enough support to the children so they can lead a normal life in their habitual social environment Hence we provide educational, medical, nutritional, legal and emotional services Once a month, we gather the children together for a day of fun and games, medical checkups, and education combined with entertainment We have formed 7 child rights clubs so far to make children aware of their rights, including the right to have access to food, medicine and education, the right of association, and the right of lawful inheritance Girls in particular are being encouraged to complete their education rather than entering into marriage with older men for financial security
