The Organization meets the "over 10%" support test through various methods of public fundraising. Specifically, the two largest fundraising events in 2009 consisted of a golf outing and a "Friends Dinner".

The golf outing attracted 64 attendees, of which 6 were directors or related parties. This event raised \$6,406 for the charitable purposes of the Organization. Most of the attendees for this event resided in Nebraska, with a few attendees from Iowa. Approximately 40 donors contributed to this event but did not participate in the golf portion.

The "Friends Dinner" attracted 125 attendees, of which 8 were directors or related parties. In addition, numerous auction items were obtained from donors. This event raised \$ 8,638 for the charitable purposes of the Organization. Again, most of the attendees for this event resided in Nebraska, with a few attendees from Iowa.

The funds raised by these events were used to support the University of Nebraska scholarships and to help subsidize the aphasia program at the Monroe-Meyer Institute. At least 13 scholarships were provided to needy students during 2009. Approximately 319 children were provided assistance in 3256 sessions at the Monroe-Meyer Institute. These children came from 9 counties in Eastern Nebraska, representing approximately 10% of the counties in the state.
