During 2009, the InfantSEE program toured the U.S. and offered no cost comprehensive eye examinations to infants between the ages of 6-12 months of age regardless of income or the availability of insurance. The locations were chosen for their geographic and socioeconomic diversity. The ultimate goal of the CDC InfantSEE project was to document if increased advertising and awareness of the InfantSEE program will lead to more infants being seen in the doctor's office.
