

Premier Health Partners (PHP), of which Samaritan Health Foundation is a member, has an incentive component for all executive and director level employees that ties a portion of their total compensation to organizational and individual objectives and outcomes. The organizational criterion is weighted according to balanced scorecard categories: Positive Work Environment (22.5%), Quality (22.5%), Customer Satisfaction (22.5%) and Major Initiatives (10%). The financial category of the scorecard is based upon net earnings of the individual hospital and the net earnings of the system as a whole. This financial target is set based on the margin required to maintain the system Aa credit rating. Vice Presidents and above incentive objectives are weighted 50% on organizational criteria and 50% on individual criteria. Directors are weighted 25% on organizational criteria and 75% on individual criteria.

The data for the survey is provided by a third party consultant group that is independent of PHP. This report includes comparability for key executives, vice presidents and director level positions. The independent comparability data is reviewed by the Executive Compensation Committee on an annual basis. This committee is comprised of three members, all of which are independent. The committee reviews in detail the compensation of the PHP CEO, PHP CFO and the hospital CEO's. Other positions are reviewed at a high level for reasonableness. All the meeting minutes are documented and kept on file along with the comparability data and the consultant report. After the the compensation committee reviews and approves the compensation actions, the process is audited by the Internal Audit Department. The Executive Compensation Committee presents the compensation actions with the PHP Board annually.
